Hildegarde Stubbs March 18, 1927 – November 21, 2019 Age 92

The San Dieguito Art Guild lost a Life Member last year. As a young woman, Hildegarde Stubbs worked as a professional florist in Beverly Hills and Santa Monica. At 22 years old, she got married, had children. "Art wasn't my greatest priority then," Stubbs said. "I wasn't doing much of it. I had never painted at that point."

When her four children grew up, Stubbs dove into oil painting. Her late husband encouraged her. And she had a lingering passion for art that could be traced to Coronado High School. In the late 1970s, she enrolled at the Laguna Beach School of Art. Later, she attended workshops from regarded water colorists like Robert E. Wood and Rex Brandt.

In the 1980s Stubbs became well known for watercolors of the California missions and Carlsbad's flower fields. She served as president of the San Diego Dieguito Art Guild in 1989 and 1991.

Hildegarde was a sweet and genltle soul who will be remembered with great fondness by many of the "old time" SDAG members.



# San Dieguito Art Guild Board Of Directors Meeting Minutes US Bank, Encinitas February 24, 2020

Call to order: 10:00 by Linda Melvin, President

IN ATTENDANCE: Jeff Brosbe, Deborah Buffington, Karen Fidel, Sharon Hoffman, Carol Korfin, Linda Melemed, Linda Melvin, Terry Oshrin, Lily Pourat, Judy Salinsky, Grace Swanson, Nancy Atherton West, Cheryl Ehlers.

ABSENT: Ellen Cramer, Julie Harris, Sandy Heath.

<u>Secretary's Notes</u> - Nancy West explained two corrections to the notes from the January minutes that she made after the original draft was sent via email.

Motion: Karen Fidel moved to approve the minutes from January with corrections and Cheryl Ehlers seconded. The motion was approved unanimously.

President's Notes - none.

<u>Treasurer's Report</u> - Linda Melemed presented the financial report summarizing that on January 31st, 2020, SDAG had total cash on hand of \$141,669. Artist sales year to date for the month ended January 31st were \$40,026, down from the prior year sales of \$41,089. Net profit Year to Date is \$49 down from the prior year profit of \$1,395.

Motion: Karen Fidel moved to accept the Treasurer's Report; Jeff Brosbe seconded. The Treasurer's Report was unanimously approved.

After approval of the Treasurer's Report the Board discussed various ideas for raising revenue. The discussion ranged from raising fees and/or commissions, eliminating the 10% discount during events when sales are highest, to creating online competitions with associated fees.

Linda Melvin asked Judy Salinsky and Cheryl Ehlers to write up a proposal with specifics for the Board to review and discuss. Jeff Brosbe commented that if we make changes to any of the current fees or commissions we will need to examine all our contracts and any other place these are referenced, including our web site.

<u>Fundraising</u> - Sharon Hoffman reported that the Mother's Day committee met on the 12th, there are currently 8 houses and the committee is working on distributing artists to each home. The order of houses is not yet worked out; the committee is working on the order and driving directions at this time. Note that Donna will need this information to continue work on the booklet.

Tickets will be ready for sale and in the gallery on April 8th. The bookmarks have been published and will be in the gallery soon.

Judy Salinsky and Grace Swanson are working on improvements for promoting the Mother's Day event on our website and will work with Carol Korfin on implementation.

Linda Melvin reported that the Artists in Charge (of each house) will meet with her at her home on March 10 at 9am. We need one more Artist in Charge.

Cheryl Ehlers reported that she will work on the liability insurance for the homeowners.

Photography for the publications is done.

<u>Publicity</u> - Grace Swanson reported that the Featured Artist for the upcoming reception is Charlene Meeker. Judy Salinsky needs the names of her paintings for publicity and will call Charlene.

The Community Center show starts Thursday with a reception on April 11, the same night as our reception. Grace will coordinate who needs to work and/or bring food to the Community Center.

Grace continued that she needs volunteers to help clean the storage unit on March 18th. Linda Melvin offered to have a garage sale of things we want to dispose of at her home on Saturday, March 21 from 7am to noon.

<u>Social Media</u> - Judy Salinsky reported that she learned how to get into activity on Instagram for the gallery. "Engagement" is when someone "likes" your work. In August of 2018 we had 485 "likes". In December of 2019 only 25. Judy gave more examples of data, including "Impressions" which is the number of times a post is seen, and "Reaches" which is when a viewer engages in the post. Judy Salinsky strongly suggests we use the Paint Rag newsletter and our website to increase the use of Instagram. She urges all artists to post photos of your work to Instagram and like your post to the gallery account. The tag @Offtrackgallery will link your post to the gallery feed.

The Board discussed the fact that not all artists understand exactly how to do this and offered a "class" to teach how to use Instagram taught by Judy Salinsky and Lily Pourat.

Calendar Report - Carol Korfin reported that calendar management is going smoothly.

<u>Wall Report</u> - Deborah Buffington reported that no one is leaving the wall and that there are seven artists on the waiting list. She also reminded all that wall renters must use the same methods for framing and hanging that are required for the monthly shows.

<u>Floor Report</u> - Lily Pourat brought up the fact that the line between what is art and what is craft can make jurying in of floor renters difficult. Especially since we still have open cubes. She posed the question - should we allow 3D art that is more toward craft than we normally have accepted. The Board discussed guidelines and Grace Swanson moved to loosen our definitions or art vs. craft. Judy Salinsky commented that art shows and should induce emotion and expression, while crafts show craftsmanship. Lily Pourat seconded Grace's motion. Carol Korfin asked to amend the motion to include close monitoring of the craftsmanship and quality of the work by the Floor Chair.

The Board voted on the motion with nine ayes and two nays. The motion was passed.

<u>Calendar Report</u> - Carol Korfin reported that from Memorial Day to Labor Day the gallery will have expanded hours and reception night hours until 9 or 9:30.

Carol Korfin reported that the website improvements are coming along nicely. Some expenses have been as expected, other not. Carol continued with some examples concluding that our web site is in its fifth year since rebuilding and we should be in good shape for some time now.

Jobs Report - Jeff Brosbe reported that the current jobs list has been sent out via email. He reminded the Board that he needs to know when a person joins or leaves a team. No luck in finding a Parliamentarian. He is hoping for a member who has been with the gallery five plus vears.

Following up from last month as the Board asked Ursula Shroder and Joyce Ford, whose responsibility it is to find outside shows and opportunities to provide a report of their work, Jeff Brosbe reported that they both have asked for different jobs.

Monthly Show - Cheryl Ehlers reported that the monthly show take in is working fine with the online registration. Cheryl also reported on judging and the difficulty with no "categories". She explained that our judges could use the following five criteria and a point system to make the judging more fair, faster, and easier. The criteria would be artistic composition, technical craftsmanship, design elements (5), originality, and creativity.

Gallery Chair Report - Terry Oshrin had emailed the Gallery Committee minutes to the Board previously and there were no questions.

Newsletter - Sharon Hoffman asked the Board if the newsletter should still run the ad for rental of cubes, and it was agreed it should stay.

Motion: Karen Fidel moved to adjourn the meeting; Linda Melemed seconded. All in favor, meeting adjourned 11:49.





## JOB GUIDELINE DIFFERENCES FOR MONTHLY SHOW PARTICIPANTS & FLOOR/WALL DISPLAY ARTISTS

# Monthly Show Participants:

1. An Artist showing in a monthly show, at the time of take-in, must commit to a job on sign-up sheets in the gallery, provided by the Monthly Show Chair. These sheets track what jobs need to be filled in the month that you are showing or the following month.

2. A Monthly Show job, on average, is approximately a 2-3 hour commitment. Upon completing the chosen job, in a timely manner, the Monthly Show Artist has then fulfilled that Monthly Show job requirement.

# Floor/Wall Display Artists:

1. A Display Artist's job is typically not a one-time occurrence, but a more significant, continuous, commitment to the gallery.

2. A Floor or Wall Display Artist needs to staff the gallery, a minimum of 12 hours (three 4-four hour shifts) each rotation.

3. An Artist can be relieved from their 3rd, 4-hour shift, each rotation, by doing a much-needed job that the Job Chair has been asked to fill, on an ongoing basis, as needed basis , of approximately 3 hours average in duration over the year.

4. Upon completing the 12-hour staffing or 2-staffing shifts plus a 3-5 hour staffing replacement job, the Floor/Wall Artist has thus fulfilled the Renter's rotation job requirements, provided that they otherwise are in good standing with the Floor/Wall Rotation Chairs.







Igor Koutsenko was born in Evpatoria, a resort city on the Crimean Peninsula on the Black Sea. His father brought Igor to the Children's Art School in his hometown after his son demonstrated artistic ability at a young age. At age eleven, Koutsenko was accepted to the adult art studio directed by the acclaimed artist Zvyagintesev who encouraged his talent. Later Igor was educated at the Penza School of Art (class of E. Iadynis) and received rigorous training in the old



E. Iadynis) and received rigorous training in the ald traditions of Russian realist art. While living in Moscow, he successfully used the Moscow art market to sell his works to Russian and foreign collectors. His experience in Moscow allowed him to fully realize husself as an independent artist.

Koutsenko immigrated to the United States in 1992 settling in Oklahoma City where he taught fine art at the University of Central Oklahoma. In 1995, he was granted permanent United States residentship as an alien of extraordinary abilities. In 1998 Koutsenko visited Southern California and was attracted by its beautiful scenery and climate that reminded him of his boyhood surroundings in Crimea. Since moving to Southern California, he continues to produce original work at his private studio in Fallbrook. Igor also teaches drawing and painting classes at the Fallbrook School of The Arts. A reception, free and open to the public, will take place on Saturday. April 11 as part of the City of Encintas' Art Night when other galleries in Encinitas will also be open.

## San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference April 24, 2020

Call to order: 10:00 by Linda Melvin, President

IN ATTENDANCE: Jeff Brosbe, Deborah Buffington, Ellen Cramer, Cheryl Ehlers, Karen Fidel, Julie Harris, Carol Korfin, Linda Melemed, Linda Melvin, Terry Oshrin, Lily Pourat, Judy Salinsky, Grace Swanson, Nancy Atherton West, Cheryl DeLain.

ABSENT: Sandy Heath, Sharon Hoffman, Marrisa Wright.

<u>President's Notes -</u> Linda Melvin thanked everyone for participating in our first ever Zoom teleconference and wished everyone good health during the global COVID 19 pandemic.

<u>Treasurer's Report</u> - Linda Melemed presented the financial report summarizing that on April 31st, 2020, SDAG had total cash on hand of \$121,600. Net profit Year to Date is \$3,351. Year to date income is a loss of \$8,443 compared to an \$18,623 loss for the same period last year. Linda also noted that since the gallery has been closed due to the COVID 19 virus, all expenses through April have been paid and she closed the books for April.

Motion: Karen Fidel moved to accept the Treasurer's Report; Carol Korfin seconded. The Treasurer's Report was unanimously approved.

<u>Secretary's Report</u> - Carol Korfin noted a correction to the February meeting minutes regarding website rebuilding which has been incorporated for the record.

Motion - Karen Fidel moved to accept the February minutes; Jeff Brosbe seconded. The minutes were approved unanimously.

<u>Special Topic: Bylaws Update by Resolution</u> - Cheryl DeLain joined this special meeting to advise the Board on a proposed change to our Guild bylaws regarding the definition of a "quorum" of the membership. A signed copy of the Resolution is attached at the end of these minutes.

Motion - Karen Fidel moved to amend the Bylaws by resolution to define a "quorum" of the membership as 15%. Grace Swanson seconded; the motion was approved unanimously.

<u>SpecialTopic: Nominating Committee</u> - Linda Melvin announced the need to set up a nominating committee for the coming year's Board of Directors. The nominating committee is made up of one board member and two others from the membership. Grace Swanson will fill the role from the Board. The open positions are: President, Treasurer, Gallery Manager, Fundraising Chair, Newsletter Editor, and Co-Calendar Chair (to share this job with two others remaining in their current role as such). Carol Korfin will fill the Parliamentarian position next year. Cheryl Ehlers noted that she needs a co-chair for the Monthly Show role and Judy Salinsky offered to fill that role.

<u>Special Topic: Wall and Floor Rental Fees</u> - With the Gallery closed for an unknown period of time due to COVID 19, the financial viability of the Guild could be in jeopardy. The Board discussed the pros and cons of numerous options to keep the gallery afloat until such time as we can open and reestablish a stream of income. The discussion focused on how to handle

wall and floor rental fees, and also create easy ways that members and customers can donate to the Guild during this difficult time. It was agreed that two <u>communications</u> would go out - one to all members, the other to renters. These email communications are included at the end of these minutes for reference.

<u>Special Topic: COVID 19 related available grants/loans</u> - Cheryl DeLain has been asked by the Board to lead a discussion for the understanding and voting upon available special small business grants and loans the government is offering during this time that could help the Guild bridge the gap financially until such time as we can reopen.

The first grant/loan is called the Economic Income Disaster Loan (EIDL). At the time the EIDL was first rolled out by the SBA, up to \$10,000 of the loan would be considered a grant as long as the money was spent on rent and utilities. Any loan amounts over \$10,000 were to be repaid at a rate of 2.75% (for non-profits) over a 30 year period with no pre-payment penalty. Our By Laws require a unanimous vote by the Board in order to incur an "indebtedness". Therefore the Board voted first for the grant and then for the loan in two separate votes.

The board discussed setting a maximum amount of the EIDL loan amount to limit our liability. Because the majority of our revenue comes from the annual Mothers Day tour (which was cancelled this year due to COVID 19) the board agreed to set the maximum amount for the loan at \$20K which is our typical income from the event.

Motion - Carol Korfin made a motion to apply for/accept the EIDL grant; Judy Salinsky seconded. The motion was approved unanimously.

Motion - Carol Korfin made a motion to apply for the EIDL loan in a maximum amount of \$20K. Also if SDAG is approved for the loan, bring the topic of accepting and use of the loan back to the board for discussion and approval; Nancy West seconded. The motion was unanimously approved.

The second available small business loan is the Payroll Protection Program (PPP) which is a vehicle to allow payment to employees and those entities who receive a 1099. These loans come from participating banks, in our case US bank. The interest rate is 1%. The loan could be forgiven if the Guild can provide documentation showing that the funds were used properly. The board discussed aspects of the liability this could create for the Guild and specifically those board members who would be required to sign for such a loan with our bank. Another unclear issue would be how the funds could be disbursed fairly to "pay employees" in our case. It was agreed and decided that this loan vehicle is not appropriate for our Guild and should not be pursued.

Gallery ReOpening - because of the unknowns relating to government guidance going forward in allowing businesses to reopen, the board agreed to take a stepwise approach and at this time agree to remain closed through May.

Motion - Ellen Cramer made a motion to remain closed through May; Karen Fidel seconded. The motion was carried unanimously.

Motion - Carol Korfin moved to adjourn the meeting; Linda Melvin seconded. Meeting adjourned at 2:59.

## San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference May 21, 2020

Call to order: 10:05 by Linda Melvin, President

IN ATTENDANCE: Jeff Brosbe, Deborah Buffington, Ellen Cramer, Cheryl Ehlers, Karen Fidel,, Carol Korfin, Linda Melemed, Linda Melvin, Terry Oshrin, Lily Pourat, Grace Swanson, Nancy Atherton West.

ABSENT: Julie Harris, Sandy Heath, Sharon Hoffman, Marrisa Wright.

<u>President's Notes</u> - Linda Melvin opened the meeting by leading a discussion of how to handle rotation fees for wall and floor renters. She said she has had a number of phone calls from members expressing concern about paying their fees when the gallery is closed. (Note that all artists displaying currently in the gallery are paid for April/May; payment would normally be due this month for June/July).

Many options were discussed including asking for full payment and seeing if any artists respond saying they cannot or wish not to pay and handling each on a case by case basis. Another option discussed was allowing for payment per month instead of for the two month period as is normal. Also discussed were only asking for 1/2 of the normal fees, and asking the broader membership for donations because the wall and floor members should perhaps not shoulder the bulk of the financial burden while closed.

It was noted that since we sent the email asking for financial support due to the pandemic with a link for donating, \$730 has been received so far from members and customers.

There was a long companion discussion regarding how concerned we should be about our solvency at this time and how we should communicate with our membership. Jeff Brosbe expressed his unease with the level of much of the Board's concern over the financial situation, feeling that we can sustain the gallery longer than other Board members feel is possible. Linda Melemed had the opportunity to clarify the details of some accounts, which are not as liquid as they may seem if we wish to keep the interest levels at the current rate. Other members reminded the Board about the length of our lease (5 years) and how we would need to be prepared financially if we were to face bankruptcy at some point during those 5 years and have to hire an attorney to break the lease.

Carol Korfin reviewed the results of the survey that had previously been sent out to display artists asking their feelings about payment of rotation fees during this time. Carol reported that the majority are willing to pay their full fees.

In terms of communication, Jeff Brosbe expressed concern about offering many options for payment or non-payment or staffing for another person instead of payment, saying that it may encourage people not to pay or to staff instead of paying.

Carol Korfin reported that the Gallery Committee proposed that a possible target date to open would be June 15 which would give time to get art down, clean the gallery per government guidelines, and rehang the art while maintaining social distancing. Carol added however that she has strong concerns about opening and the safety for our members that would come back to staff there.

Cheryl Ehlers reviewed the city of Encinitas published guidelines (copied to the board prior to the meeting) for reopening. She described the steps as 1) Clean the gallery, 2) Require customers to wear face masks and maintain 6 foot social distance, and 3) Require staffers to wear face masks and maintain social distance.

Cheryl Ehlers also stated that the Guild must disclose our Form 990 financial report because she had heard from some members expressing concern about asking for full payment while we are closed because we have a \$100,000 savings account. Linda Melemed replied that the President gives a full financial report to the entire membership at the annual meeting every year, and a copy of the Form 990 report is always in the gallery and can be reviewed.

Back to the topic of re-opening the gallery, Cheryl Ehlers continued by saying we need a Safety Officer to sign the paperwork that is required to be displayed at the gallery door when we re-open certifying that we have and are following the City of Encinitas safety and cleanliness guidelines and she offered to take that role and sign the paperwork.

Carol Korfin asked specifically are there guidelines regarding whether those persons that have been defined as "vulnerable" (over 65, those with underlying health conditions, those with compromised immune systems) should come back to work. Cheryl Ehlers said no, once again reviewing the city guidelines.

The Board discussed the steps to reopen in terms of cleaning staff, gloves, hand sanitizer, wipes, and moving to credit card only transactions.

Grace Swanson proposed a timeline for preparing to re-open as the following: all art out of the gallery by May 31st; clean the gallery June 1st to 2nd; rehang art while maintaining social distance June 3rd to 7th; a soft opening June 8th to 14th; and full reopening on June 15th. Grace will send an email with this information (or similar) to all board members for their feedback.

Karen Fidel asked if we know if the bathroom is open? Linda Melvin will contact the landlord and find out when the bathrooms will be cleaned and open. Many agreed we cannot open without a bathroom!

The discussion moved to the Monthly Show. Cheryl Ehlers said she will coordinate the take down of the current work with Lily Pourat and Debi Buffington. Cheryl continued that the walls would remain empty for the second half of June with Monthly shows resuming in July. Cheryl added that the take in will be streamlined to fewer workers in order to maintain social distance and that payment would need to be done online with registration. She continued that we need a paypal button with no specified amount that would link the member to paypal where they would enter what they owe. Also monthly volunteer jobs would need to be signed up for online.

<u>Secretary's Report</u> - Nancy West noted she would change the reference to "two" communications to members in the last meeting minutes to "one".

Motion - Karen Fidel moved to accept the previous month's minute; Linda Melemed seconded. The minutes from April were approved unanimously.

<u>Treasurer's Report</u> - Linda Melemed reported that on April 30th, 2020, we had total cash on hand of \$121,988. Artist sales year to date for the month ended April 30th were \$51,626 down from the prior year sales of \$61,256. Net loss Year to date is \$8,147 compared to the prior year loss of \$18,623. The \$10,000 difference from the prior year is due to \$7,000 in Mother's Day

expensed from the prior year and \$1,000 in loss of art sales commission and loss of Mother's Day artist fees.

Linda reported she was pleased to see on our bank statement but the government had deposited a \$1000 EIDL grant. Linda also reminded the board that there is government Pandemic Assistance for those that are self employed. The details of this program had been sent out to all members.

Linda also reported that the Guild has received a notice that we are listed as a creditor in a bankruptcy settlement of Lambert, owner of BK Books. She noted that she would contact Cheryl DeLain as to how to proceed.

Motion: Jeff Brosbe moved to accept the Treasurer's Report; Karen Fidel seconded. The Treasurer's Report was unanimously approved.

<u>Membership</u> - Linda Melemed brought up the fact that the Guild was planning to raise the membership dues this August and suggested that we could offer a prepayment incentive to drive some near term cash flow. The Board discussed the fact that we have not raised dues in two years, and that the family membership add on of \$25 is too low. Also discussed was when to communicate this and all agreed we should wait until the gallery is open and things are beginning to settle down.

Motion - Karen Fidel made a motion for the SDAG to raise single member dues from \$95 to \$105 as of September 1st, the family level membership be raised to \$150, and that a prepayment incentive option at the current dues rate for single and family memberships would be offered if payment is received before September 1st. Jeff Brosbe seconded the motion. The motion was unanimously passed.

<u>Publicity/Nomination Committee</u> - Grace Swanson reported that she had discontinued the Coast News advertisement and would reinstate it in a couple weeks.

Grace continue with progress of the Nominating Committee saying they have a few "maybes", but not all positions are filled at this time. They have "maybes" for Treasurer, Co-Gallery Chair, and Co-Monthly Show Chair.

<u>Calendar</u> - Carol Korfin told the board that Bea Gold is making and selling face masks with the proceeds going to the gallery.

Carol continued that the Gallery Committee foresees a slow start when reopening, and had considered shorter hours but will wait to see what happens. She added that they are eliminating overlapping shifts for training and also the later summer hours. Training methods will need to be addressed as well in light of required social distancing.

<u>Website</u> - Carol Korfin reported that to save costs we are in a holding pattern now and that we will support any breaks or issues with the website but not spending on improvements.

<u>Floor Chair Report</u> - Lily Pourat reported that we have one new person coming onto the floor. She continued that we have one open cube. Some artists want to sell face masks, and we also have identified a company that will make face masks with our artwork on them if we would like. Lily confirmed that she would be coordinating the take out of art with the other Chairs (Debi Buffington and Cheryl Ehlers) in order to maintain social distance, and that the virtual jewelry sales platform is up and running.

<u>Jobs Chair Report</u> - Jeff Brosbe reported that he has been watching changes in the Board and floor and wall renters is looking at needs for new jobs. Jeff asked to be kept up to date on

floor and wall renter changes going forward as well as any changes from the Nominating Committee.

<u>Gallery Manager Report</u> - Terry reported that she will manage the cleaning of the gallery with our current service when we agree on the exact dates.

<u>Monthly Show Chair Report</u> - Cheryl Ehlers will work with Carol Korfin to get the paypal button needed on the website for payment of monthly show fees. Cheryl also confirmed she will be changing staffing for take in day and will work with Jeff Brosbe as to how this affects jobs.

Cheryl Ehlers reported that she will eliminate professional judges for now thus saving the gallery \$100 per month. The judging will be done on a point system that is used by the San Diego County Fair and the Refections program.

Cheryl Ehlers expressed her strong opinion against adding more art to the Monthly show as suggested by the Gallery Committee, stating that this would mean displaying art too low on the wall, or in less than ideal lighting and she feels this is unfair to the artists.

Motion - Karen Fidel made a motion to adjourn; Linda Melemed seconded. The motion was passed unanimously.

## **NEW SAFETY PROCEDURES FOR OPERATING GALLERY DURING COVID19**

All staffers will be asked to sign a **guidelines sheet** recommended by County of San Diego. All staff will either **take their own temperature** before coming to staff or ascertain that they do not have COVID19 symptoms (cough, shortness of breath, trouble breathing, or two of the following – fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell). All staffers will **wear a mask** when at gallery and will follow all procedures which the Gallery has from the County of San Diego and will have posted on the front door. We will not have overlapping shifts or summer late hours this year.

- 1. Don't use binders unless absolutely necessary. (If you have to use them, clean cover and pages [this will smear] with a disinfectant wipe after use)
- Don't use Member Directory. On side cart, under the plastic will be a list of all members and their phone numbers to use when calling member after a sale is made and to call next day staffers. USE YOUR OWN CELL PHONE RATHER THAN THE GALLERY PHONE.
- Under the glass on the desk will be these procedures and calendars, as well as instructions for cleaning credit card machine. Leave them under the glass.
   DO NOT SPRAY LIQUID ON CREDIT CARD MACHINE.
- 4. Don't use nametags.
- 5. We will not be taking any cash sales, only credit/debit card sales. Let customer insert own card when it asks for credit or debit card.
- 6. We will not enter sales into sales log for this time period. When a staffer staffs, they can check the pink copy of the old sales receipt books, which will be left in the side cart drawer.
- 7. It will probably be very slow in the gallery. If you want to bring something to read or do during the time no customers are in the gallery that is OK for now, as long as no customers are in the gallery.

# WHEN YOU ENTER GALLERY IN THE MORNING:

- 1. Have your mask on and keep it on.
- 2. Bring lock box and key in with you and open door all the way.
- 3. Turn on lights and unlock back door.
- 4. Wear rubber glove when you use a disinfectant wipe to clean key, lockbox, door handles, light switches, frame of sign desktop, top of desk and side cart, desk drawers fronts and handles and side car drawer/door fronts and handles, and pens & pen holders, stapler, calculator and tape dispenser on the desk. Put sign out front.

- 5. In back office if you use computer, wipe with a disinfectant wipe as well as file drawer handles or safe handle.
- 6. Wash your hands in back office at sink. Soap and paper towels will be by sink, along with trash container with plastic liner. (Happy Birthday twice!) ONLY STAFF CAN WASH HANDS IN BACK OFFICE, CUSTOMERS WILL NEED TO USE RESTROOM FACILITIES.

WHEN CUSTOMERS COME IN: There will be a sign on the on the door with government and our guidelines. Door will be left open. No more than 10 customers allowed in at one time. Floor will be marked with safe distance markers [how?]. A station will be set up at entry to gallery or next to desk that will have disposable masks, hand sanitizer and disinfectant wipes on it. A trash can with plastic liner will be there for disposal of paper masks and wipes.

- If they are not wearing a mask, ask them to put one on from the box at the front door. If they have a mask on but it is not up, ask them to please put their mask up. They are not to come in without a face covering. If they say they don't want to wear a mask, tell them we will be glad to welcome them back in the future when they no longer need to, but you are required to adhere to our procedures dictated by the county.
- 2. Ask each customer to use hand sanitizer in order to keep everything in the gallery sanitized.
- 3. Sales will be made by credit / debit card only. There will be two pen holders on the desk. One marked "Sanitized". One marked "Used". Have then use one from the sanitized holder and put it in the used holder. At end of your shift, wipe down the pens in the used holder and put them into the sanitized holder. DON'T enter sales in sales log, but DO ENTER IT ON YOUR WHITE ENVELOPE and put your envelope in the safe at end of your shift.
- 4. At the end of your shift wipe down all surfaces as you did in the beginning of it.
- 5. Ask them [them who?] to read all instructions above again.

# WHEN AFTERNOON SHIFT ARRIVES:

- 1. Read all instructions from the top and follow steps that apply.
- 2. When preparing to leave, after putting your envelope in the safe, wipe down back office surfaces you touched, lock back door and wipe down handle, wipe down desk and cart surfaces, pens & pen holders, stapler, tape dispenser, calculator, credit card machine, light switches, bring in sign and wipe frame, lock door and wipe down handle, key and lockbox after putting it back.

# SAN DIEGO READY TO RECOVER

The coronavirus pandemic has shut down or significantly altered most of the economy, testing the resiliency of all San Diegans. Necessary public health measures to prevent the spread of the virus have halted tourism, shuttered restaurants and bars, forced many to work from home, severely limited most businesses from interacting with their customers, and caused unemployment and uncertainty for tens of thousands in the San Diego region.

As hospitals build out the capacity to care for COVID-19 patients, and state and local governments take initial steps to reopen parts of our society, our community must be prepared with strategies that return San Diegans to work while still preventing the spread of the virus. Our goal is to ensure San Diego will be ready to safely begin its economic recovery when state and local health orders are lifted.

On April 17, 2020, City of San Diego Mayor Kevin Faulconer and County Supervisor Greg Cox launched a binational and bipartisan group of nearly thirty industry experts and civic leaders to advise how businesses can prepare to safely reopen.



### San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference May 21, 2020

Call to order: 10:05 by Linda Melvin, President

IN ATTENDANCE: Jeff Brosbe, Deborah Buffington, Ellen Cramer, Cheryl Ehlers, Karen Fidel,, Carol Korfin, Linda Melemed, Linda Melvin, Terry Oshrin, Lily Pourat, Grace Swanson, Nancy Atherton West.

ABSENT: Julie Harris, Sandy Heath, Sharon Hoffman, Marrisa Wright.

<u>President's Notes -</u> Linda Melvin opened the meeting by leading a discussion of how to handle rotation fees for wall and floor renters. She said she has had a number of phone calls from members expressing concern about paying their fees when the gallery is closed. (Note that all artists displaying currently in the gallery are paid for April/May; payment would normally be due this month for June/July).

Many options were discussed including asking for full payment and seeing if any artists respond saying they cannot or wish not to pay and handling each on a case by case basis. Another option discussed was allowing for payment per month instead of for the two month period as is normal. Also discussed were only asking for 1/2 of the normal fees, and asking the broader membership for donations because the wall and floor members should perhaps not shoulder the bulk of the financial burden while closed.

It was noted that since we sent the email asking for financial support due to the pandemic with a link for donating, \$730 has been received so far from members and customers.

There was a long companion discussion regarding how concerned we should be about our solvency at this time and how we should communicate with our membership. Jeff Brosbe expressed his unease with the level of much of the Board's concern over the financial situation, feeling that we can sustain the gallery longer than other Board members feel is possible. Linda Melemed had the opportunity to clarify the details of some accounts, which are not as liquid as they may seem if we wish to keep the interest levels at the current rate. Other members reminded the Board about the length of our lease (5 years) and how we would need to be prepared financially if we were to face bankruptcy at some point during those 5 years and have to hire an attorney to break the lease.

Carol Korfin reviewed the results of the survey that had previously been sent out to display artists asking their feelings about payment of rotation fees during this time. Carol reported that the majority are willing to pay their full fees.

In terms of communication, Jeff Brosbe expressed concern about offering many options for payment or non-payment or staffing for another person instead of payment, saying that it may encourage people not to pay or to staff instead of paying.

Carol Korfin reported that the Gallery Committee proposed that gallery closing be extended to

June 15 rather than June 30, so we could reevaluate if things change before then. Carol added however that she has strong concerns about opening and the safety for our members that would come back to staff there.

Cheryl Ehlers reviewed the County of San Diego published guidelines (copied to the board prior to the meeting) for reopening. She described the steps as 1) Clean the gallery, 2) Require customers to wear face masks and maintain 6 foot social distance, and 3) Require staffers to wear face masks and maintain social distance.

Cheryl Ehlers also stated that the Guild must disclose our Form 990 financial report because she had heard from some members expressing concern about asking for full payment while we are closed because we have a \$100,000 savings account. Linda Melemed replied that the President gives a full financial report to the entire membership at the annual meeting every year, and a copy of the Form 990 report is always in the gallery and can be reviewed.

Back to the topic of re-opening the gallery, Cheryl Ehlers continued by saying we need a Safety Officer to sign the paperwork that is required to be displayed at the gallery door when we re-open certifying that we have and are following the County of San Deigo safety and cleanliness guidelines and she offered to take that role and sign the paperwork.

Carol Korfin asked specifically are there guidelines regarding whether those persons that have been defined as "vulnerable" (over 65, those with underlying health conditions, those with compromised immune systems) should come back to work. Cheryl Ehlers said no, once again reviewing the city guidelines.

The Board discussed the steps to reopen in terms of cleaning staff, gloves, hand sanitizer, wipes, and moving to credit card only transactions.

Grace Swanson proposed a timeline for preparing to re-open as the following: all art out of the gallery by May 31st; clean the gallery June 1st to 2nd; rehang art while maintaining social distance June 3rd to 7th; a soft opening June 8th to 14th; and full reopening on June 15th. Grace will send an email with this information (or similar) to all board members for their feedback.

Karen Fidel asked if we know if the bathroom is open? Linda Melvin will contact the landlord and find out when the bathrooms will be cleaned and open. Many agreed we cannot open without a bathroom!

The discussion moved to the Monthly Show. Cheryl Ehlers said she will coordinate the take down of the current work with Lily Pourat and Debi Buffington. Cheryl continued that the walls would remain empty for the second half of June with Monthly shows resuming in July. Cheryl added that the take in will be streamlined to fewer workers in order to maintain social distance and that payment would need to be done online with registration. She continued that we need a paypal button with no specified amount that would link the member to paypal where they would enter what they owe. Also monthly volunteer jobs would need to be signed up for online.

<u>Secretary's Report</u> - Nancy West noted she would change the reference to "two" communications to members in the last meeting minutes to "one".

Motion - Karen Fidel moved to accept the previous month's minute; Linda Melemed seconded. The minutes from April were approved unanimously.

<u>Treasurer's Report</u> - Linda Melemed reported that on April 30th, 2020, we had total cash on hand of \$121,988. Artist sales year to date for the month ended April 30th were \$51,626 down from the prior year sales of \$61,256. Net loss Year to date is \$8,147 compared to the prior year loss of \$18,623. The \$10,000 difference from the prior year is due to \$7,000 in Mother's Day

expensed from the prior year and \$1,000 in loss of art sales commission and loss of Mother's Day artist fees.

Linda reported she was pleased to see on our bank statement but the government had deposited a \$1000 EIDL grant. Linda also reminded the board that there is government Pandemic Assistance for those that are self employed. The details of this program had been sent out to all members.

Linda also reported that the Guild has received a notice that we are listed as a creditor in a bankruptcy settlement of Lambert, owner of BK Books. She noted that she would contact Cheryl DeLain as to how to proceed.

Motion: Jeff Brosbe moved to accept the Treasurer's Report; Karen Fidel seconded. The Treasurer's Report was unanimously approved.

<u>Membership</u> - Linda Melemed brought up the fact that the Guild was planning to raise the membership dues this August and suggested that we could offer a prepayment incentive to drive some near term cash flow. The Board discussed the fact that we have not raised dues in two years, and that the family membership add on of \$25 is too low. Also discussed was when to communicate this and all agreed we should wait until the gallery is open and things are beginning to settle down.

Motion - Karen Fidel made a motion for the SDAG to raise single member dues from \$95 to \$105 as of September 1st, the family level membership be raised to \$150, and that a prepayment incentive option at the current dues rate for single and family memberships would be offered if payment is received before September 1st. Jeff Brosbe seconded the motion. The motion was unanimously passed.

<u>Publicity/Nomination Committee</u> - Grace Swanson reported that she had discontinued the Coast News advertisement and would reinstate it in a couple weeks.

Grace continue with progress of the Nominating Committee saying they have a few "maybes", but not all positions are filled at this time. They have "maybes" for Treasurer, Co-Gallery Chair, and Co-Monthly Show Chair.

<u>Calendar</u> - Carol Korfin told the board that Bea Gold is making and selling face masks with the proceeds going to the gallery.

Carol continued that the Gallery Committee foresees a slow start when reopening, and had considered shorter hours but will wait to see what happens. She added that they are eliminating overlapping shifts for training and also the later summer hours. Training methods will need to be addressed as well in light of required social distancing.

<u>Website</u> - Carol Korfin reported that to save costs we are in a holding pattern now and that we will support any breaks or issues with the website but not spending on improvements.

<u>Floor Chair Report</u> - Lily Pourat reported that we have one new person coming onto the floor. She continued that we have one open cube. Some artists want to sell face masks, and we also have identified a company that will make face masks with our artwork on them if we would like. Lily confirmed that she would be coordinating the take out of art with the other Chairs (Debi Buffington and Cheryl Ehlers) in order to maintain social distance, and that the virtual jewelry sales platform is up and running.

<u>Jobs Chair Report</u> - Jeff Brosbe reported that he has been watching changes in the Board and floor and wall renters is looking at needs for new jobs. Jeff asked to be kept up to date on

floor and wall renter changes going forward as well as any changes from the Nominating Committee.

<u>Gallery Manager Report</u> - Terry reported that she will manage the cleaning of the gallery with our current service when we agree on the exact dates.

<u>Monthly Show Chair Report</u> - Cheryl Ehlers will work with Carol Korfin to get the paypal button needed on the website for payment of monthly show fees. Cheryl also confirmed she will be changing staffing for take in day and will work with Jeff Brosbe as to how this affects jobs.

Cheryl Ehlers reported that she will eliminate professional judges for now thus saving the gallery \$100 per month. The judging will be done on a point system that is used by the San Diego County Fair and the Refections program.

Cheryl Ehlers expressed her strong opinion against adding more art to the Monthly show as suggested by the Gallery Committee, stating that this would mean displaying art too low on the wall, or in less than ideal lighting and she feels this is unfair to the artists.

Motion - Karen Fidel made a motion to adjourn; Linda Melemed seconded. The motion was passed unanimously.

Meeting adjourned at 12:00

On May 27, 2020, Linda Melvin, President, sent an email request to all Board members for a yes or no vote on reopening the gallery per the County of San Diego guidelines, and the schedule laid out by Grace Swanson.

Motion - Nancy West made a motion to reopen the gallery as discussed in our May Board meeting via Zoom, and per the detailed plans laid out in subsequent emails in accordance with the requirements of the county of San Diego. Karen Fidel seconded the motion. All members voted in yes in favor of reopening via email.

## Proposed motion for vote by SDAG Board of Directors: Defining a "Member's Quorum"

Given the unusual and uncertain economic climate, we should consider adding a Bylaw provision that the Legal Committee wanted to propose to the Board last summer before we got sidetracked by other Bylaws issues.

Last year our attorney told us that certain guild issues, especially certain major financial issues (such as mergers, sale of assets, etc.), require a vote by a quorum of guild members. Absent a Bylaws provision stating otherwise, California law defines a membership quorum as one-third of the members. Our current Bylaws don't define a quorum which means SDAG currently requires a response from at least 33.33% of guild members to move forward on certain major issues The only voting that SDAG members have done in recent years is to vote annually for Board members and our response rate for that major event averages around 20-25%.

Our attorney said we could change the Bylaws to allow for a smaller number than one-third to constitute a member's quorum. In fact, he said many non-profits choose a lower percentage because most members of non-profits join for reasons other than a desire to manage and in general tend to be disinterested.

Given the current economic climate, if we have to do something extraordinary to survive (ie, a merger, etc.) and if any of those decisions require a vote by a quorum of the membership, we may not get a one-third response rate which means we may miss out on potential opportunities. This may be a good time to vote in a Bylaw provision defining a membership quorum as 20% or even less. This should be voted on before the next Board is sworn in in August so that it is in effect for the next fiscal year.

2. APPENDIX B, Article II, shall add the following Section 4:

QUORUM: For those votes that require a quorum of voting Members, and except as otherwise provided in these Bylaws, 15% of the eligible Membership shall constitute a quorum.

2. APPENDIX B, Article II, shall add the following Section 4: QUORUM: For those votes that require a quorum of voting Members, and except as otherwise provided in these Bylaws, 15% of the eligible Membership shall constitute a quorum.

The Board directs that these resolutions be filed with the Minutes of the proceedings of the Board of Directors of this corporation.

"I will have about 35., 1-gallon containers with two Irises, and about 20., 3-gallon containers with three Irises. These plants will be delivered to Linda Melvins residence. Any guild members and their friends are welcome to make a donation of \$10 for the 2-plant containers, and a donation of \$12 for the 3-plant containers."

"Some of my Irises have already blossomed, as seen in the photos, and some have not yet bloomed. The best time for planting Irises is the spring or fall seasons, but they can be planted any time of the year and still survive. They like a sumy location, soil with good drainage, and not too much water."

"The Iris leaves usually take a couple of weeks to die back towards the end of summer. Once leaves are all brown, trim them back to about 6-8 inches above the ground. If they don't turn brown, you can just leave them in for Springtime blooms...After trimming, it is a good time to divide the bulbs or rhizomes."

"Division of bulbs and rhizomes only needs to be done every 2-3 years. Consult gardening books if needed, but honestly.....I do almost nothing to my Irises and rarely divide them, and they continue to flourish. The first ones I planted are about 12-15 years old and they spent 2 years in pots, before they received their spot in our current yard!"

"The White flowers are such great subject matter for painting or they make a great statement lining a pathway....I like them in connection with the Purple

#1 - Two layers of enamel fired on, then the design is laid out in cloisonne wires and fired again.

#2 - Several layers of enamel applied and each one fired. No pink or red colors used until the last firings.

#3 - Several more layers of enamel applied and fired separately to develop the pink and orange shades, after which the piece is polished and set.






#### Kay Teeters (process of making a necklace with pendant)

"Here are some photos of some jewelry pieces I am currently working on. When they're finished they will be similar to the green pendant on the bronze background."

"To make them, I first make some clear glass disks with my oxygen/propane torch and anneal them in my kiln. Then I use a diamond bit to create texture on the back side of the disk. Next I use colored pencils to add color to the textured side and heat it on a cup warmer to allow the wax in the color to seep into the texture, brush it in and then spray it with a fixative to hold the color in place."


"Then I make slightly larger disk from bronze clay, fire the clay to create a sintered bronze disk and will eventually rivet the glass disk to the bonze one. Next I will make some more bronze or glass embellishments to add to the piece and add chain and a ring and bar clasp to finish it."










<u>Special meeting regarding the SBA-EIDL</u> - Linda Melvin reviewed for the members the email previously sent discussing the pros and cons of accepting the US Small Business Administration Economic Injury Disaster Loan. The memo discussed the background of the loan as it relates to SDAG, reasons for a yes vote, one reason for a possible no vote, and a request to members for additional pros and cons. The memo is attached to these minutes for reference.

Carol Korfin reported that she did not receive any additional pros or cons for the vote.

One member asked to abstain initially but when it was explained that for this type of vote regarding taking on an indebtedness, the vote would need to be unanimous. The Board discussed how the loan would be used to pay business expenses, and since the pandemic could adversely affect the gallery operations and profitability for some time into the future, it was pragmatic to take the loan for security with the intent to pay it off as soon as possible.

Motion: Jeff Brosbe made a motion to accept the SBA-EIDL; Carol Korfin seconded. The motion was passed by unanimous vote.

Meeting was adjourned.

### San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference June 29, 2020

Call to order: 10:08 by Linda Melvin, President

IN ATTENDANCE: Jeff Brosbe, Deborah Buffington, Cheryl Ehlers, Karen Fidel, Carol Korfin, Linda Melemed, Linda Melvin, Terry Oshrin, Lily Pourat, Grace Swanson, Nancy Atherton West, Marissa Wright.

ABSENT: Ellen Cramer, Julie Harris, Sandy Heath, Sharon Hoffman.

<u>President's Notes</u> - Linda Melvin noted that the date on the agenda sent via email for this meeting was in err and should read June 29, 2020.

Linda Melvin led a discussion of possible additional ways to increase revenue during the pandemic such as traveling shows at various outdoor places of interest in the area. Some locations discussed were Bumann Ranch in Encinitas, the Heritage House, private homes (outdoors) and the Flower Fields. The Board discussed how the Guild would make money, whether displaying artists would be charged, and commission structure. The discussion was brainstorming in nature and Linda Melvin asked the Board to continue to think about creative ways we can generate more income for our artists and the Guild.

<u>Monthly Show</u> - Cheryl Ehlers reported that for the next monthly show she has 23 to 24 participants bringing in \$673 in registration fees. A normal month pre-pandemic would typically yield \$800-\$900. Members were pleased that our first monthly show since the pandemic is doing fairly well.

<u>Secretary's Report</u> - Linda Melvin asked for a motion to approve the Secretary's minutes from the precious month's meeting.

Motion - Grace Swanson moved to accept the previous month's minutes; Debi Buffington seconded. The minutes from May were approved unanimously.

<u>Treasurer's Report</u> - Linda Melemed reported that as of May 31, 2020 we had total cash on hand of \$116,353. Artist sales year to date for the month ended May 31st were \$51,836 down from the prior year sales of \$69,393. Net loss Year to Date is \$14,148 compared to the prior year profit of \$1,730. The \$12,418 difference from the prior year is due to the loss of Mother's Day income and commission from art sales. Linda Melemed further reported the current month's income through June 23rd as \$2,363.

Carol Korfin posed a question regarding credit card fees increasing from roughly \$2,000 to \$3,480. Linda Melemed agreed to investigate the reason for the higher fees.

Motion: Karen Fidel moved to accept the Treasurer's Report; Jeff Brosbe seconded. The Treasurer's Report was unanimously approved.

<u>Membership</u> - Karen Fidel reported that the online membership renewal is available.

<u>Publicity/Nomination Committee</u> - Grace Swanson reported nothing new in Publicity, but that she would send another eblast to customers reminding them that we are open and encouraging them to come see us in the gallery.

Grace continued with progress of the nominating committee for next year's Board of Directors, saying she would present the slate at the next meeting. The biggest challenge is not having a candidate for President. Grace continued that the committee is not seeking a Fundraising

Chair at this time, since there are no real fundraising activities allowed. Grace will take on Social Media, but will be requesting a web overseer from Jeff Brosbe, Jobs Chair.

Grace Swanson continued that Carol Korfin would be the candidate for Treasurer, and Judy Richardson will seek the Parliamentarian position.

Grace shared with the Board that she has been researching on-line art sales methods like Shopify and suggested the Board create a team to pursue this for our members. She reported that customers could be directed to our Shopify online "store" directly from our Guild website. Shopify could have it's own paypal accounts for payments and shipping would be the responsibility of each artist.

Carol Korfin added that there is a service in Encinitas that would pick up sold items from the gallery, package them professionally and ship to the customer. There is a cost but the assurance of consistency and safety in packaging and delivery might be worth the cost.

Jeff Brosbe added that you can go into a UPS (or similar) store and they will do this for you also. There could be options depending upon from where the item was shipping - the gallery or an artist's home.

Grace suggested the committee should give thought to how to monitor the quality of items offered in order to maintain a quality of artwork that is consistent with what we offer in the gallery.

Lily Pourat asked to be on the committee with Grace, as she has also been doing research in this area.

Grace agreed to send a questionnaire to the membership to gauge interest in participating and/ or being on the committee.

<u>Calendar</u> - Carol Korfin asked the Board to go online to the calendar and pick two possible dates for August and September and send them to her via email. Carol asked for feedback from members who have staffed as to how things are going under the new requirements. Feedback was generally positive with the exception of the mysterious disappearance of 50 face masks in a short time. Carol reported that she had sent an email to staffers reminding them that they must wear their own mask, and only give one out from the gallery supply if a visitor does not have their own. Further, that the gallery masks are not for the use of staffers or worse, taken home.

Carol Korfin reported on the City of Encinitas small business grant program and our application. The city has \$250,000 slated for providing grants from \$2,000 to \$10,00 to small deserving businesses during the hardship of the pandemic and Cheryl DeLain has stepped up to make an application on behalf of the Guild.

Carol Korfin asked the Board for a motion to name her as a Board member acting as agent for the Guild to sign for the loan portion of the Economic Injury Disaster Loan, but specifically not personally responsible.

Motion: Grace Swanson made a motion that Carol Korfin, as an elected Board Member and agent for San Dieguito Art Guild and as approved by motion of its Board of Directors, be able to provide signature for the federal Economic Injury Disaster Loan, and is specifically not responsible individually. Karen Fidel seconded the motion. The motion was passed by unanimous vote.

<u>Wall Chair Report</u> - Debi Buffington reported that one half wall renter is changing to the floor. A new wall renter will take his place and be trained accordingly.

Debi continued that she had created a schedule for the next wall rotation to take place in a "domino effect" manner where one artist takes their work down and moves it to an already empty space and another moves into their vacated space, and so on, in order to provide for

good social distancing. Debi continued that she would need up to two helpers per shift; Jeff Brosbe asked Debi to get a description of the helpers' jobs to Bobby Harrington for assignment.

<u>Floor Chair Report</u> - Lily Pourat reported that two new people will be in cubes, one from the half wall and one new artist. Lily continued that she has organized cube rotation with two artists switching with one another at a time, in order to social distance.

<u>Jobs Chair Report</u> - Jeff Brosbe asked the Board to please review his email with the latest jobs report for accuracy. Linda Melvin brought up that Lily Pourat, Floor Chair, needs a person to draw up the diagram of the floor rotation of cube artists every two months. Grace is currently drawing up the wall rotation "map". Both jobs could be done by the same person. It was decided Grace would send Jeff a job description of both and he would recruit another member for this job.

Jeff Brosbe brought up the fact that many jobs are not able to be performed at this time during the pandemic, an example being anything related to Hospitality. The Board discussed whether the persons in "suspended" jobs should be reassigned elsewhere. Carol Korfin noted that the calendar may need extra shift workers for some time forward due to members being unable or unwilling to work in the gallery because of the pandemic, and their individual health or family situation. It was agreed that persons in "suspended" jobs be left in those positions, but be eligible to be called upon to perform other temporary additional work such as staffing on an as needed basis.

The Board discussed the impact of Holly Wolfe moving out of state, leaving the wall and also the jury for 3D art and jewelry. Several members voiced their support for Lily being the replacement juror as she is a sculptor herself.

<u>Gallery Manager Report</u> - Terry Oshrin and members of the Gallery Committee reported that the plexiglas shield has been installed at the desk to protect staffers and visitors during interaction and/or transactions. The restrooms in the complex will now be open until 8pm.

Finally the Board discussed upcoming events such as the next jury session and the installation of the new Board in August. Since these are normally "in person" events, the Board will have to decide whether these can be held as usual or online this year. This will be decided closer to the dates of the events.

Motion - Jeff Brosbe made a motion to adjourn; Carol Korfin seconded. The motion was passed unanimously.



### My Dad - Jack Teeters, by Kay Teeters

"My dad, Jack Teeters, was an artist and teacher. He grew up on a farm in Kansas during the Depression. He and my mom met in a college art class. Dad served as a gunner on an A-20 Havoc in WWII and while he was stationed in the South Pacific he sketched scenes of military life and made wood carvings from scraps of native hardwood species he found in New Guinea and the Philippines; he always carried a small piece of sandpaper in his pocket so he could sand his carvings while he was waiting in line for chow.

After the war, he married mom, finished his college degree and became a teacher, teaching high school art and craft classes. After we moved from Kansas to Oregon, he spent many weekends and summers painting landscape scenes all over Southern Oregon. Our trips to the Oregon beaches always involved hunting for pieces of driftwood, especially Oregon Myrtlewood, for sculpture projects. In the late 1950s he and three other local artists founded the Rogue Valley Art Association and Rogue Gallery; the gallery and art education programs are still going strong today. https://www.roguegallery.org/organization.html

Having an artist father meant that my sibs and I grew up with our hands in finger paint and clay; there was never any shortage of art materials in our house. As a teacher in a perpetually under-funded department, dad was an accomplished scrounger of things his students could use for art projects, and when macrame became popular, he checked a book out of the library and taught himself how to tie macrame knots so he could teach the techniques to his students. Several of his students went on to become artists or teachers themselves."

"My dad Charles Hauser was born on the San Carlos Indian Reservation in Globe, AZ. He was adopted from a Los Angeles orphanage at age 4, grew up in Beverly Hills, majored in engineering at UCLA, then married. President's Notes - Linda Melvin reported that efforts to find suitable outdoor venues for potential sales during the pandemic had proven fruitless. For example, the Flower Fields charges \$5,000 per day to use their grounds! Also it was learned that at this time the cities are not permitting additional outdoor events.

The Guild received a letter from member Diane Abadie asking to see the organization's financial information. Linda Melemed stated that the Guild's tax return is in the gallery office and available for members to review. (Note that there is a complete financial report given at th annual members meeting in January).

Linda raised the idea regarding opening the gallery for shorter hours since traffic and sales has been at times lighter since the reopening. Carol Korfin had done some research with respect to the other businesses in the Lumberyard Shopping Center and reported the following:

A couple of years ago the center had 50 businesses. Now there are 31 businesses with four to six of those being non-retail. Carol called most of the retail operations and most are open.

Of those open, seven open at 11:00 or 11:30 and remain open until 6:00 to 10:00. Ten other businesses open earlier because they serve breakfast. St. Tropez which is close to us is open from 8:00 to 3:00 Sunday though Tuesday, and 8am to 8pm the other days. It was mentioned we could ask staffers to record the timing of traffic. Lily Pourat reported that when she worked recently on a Thursday she had the most sales ever and it seemed people were hungry to be out shopping Overall the board agreed to keep the hours the same and continue to track visitors and sales as normal at this time.

Linda Melvin reported a member wrote to her expressing his frustration that he was told he had too many shrink wrapped pieces in the gallery. There is currently a limit of pieces per artist. He suggested we increase this limit, but the board agreed that space limitations preclude an increase at this time. Secretary's Report - Linda Melvin asked for a motion to approve the Secretary's minutes from the precious month's meeting.

Motion - Karen Fidel moved to accept the previous month's minutes; Jeff Brosbe seconded. The minutes from June were approved unanimously.

Treasurer's Report - Linda Melemed reported that as of June 30th 2020 we had total cash on hand of \$121,554. Artist sales year to date for the month ended June 30th were \$56,261 down from the prior year sales of \$77,315. Net loss Year to Date is (\$13,712) compared to the prior year profit of \$1,424. The difference from the prior year is due to the loss of Mother's Day income and closure of the Gallery for several months due to Covid-19 resulting in lower commissions from loss of art sales. Sales for June 8-30, 2020 = \$4,425. Sales for June 1-30, 2019 = \$7,922.

So far for the month of July (1st to the 17th) sales are approximately \$2,000.

Carol Korfin mentioned that the floor rotation fees seemed low at \$1,150. Lily Pourat explained that some display artists pay yearly and others pay every two months which could be a factor. Lily explained her payment acceptance and receipt review process in detail, adding that she would go back and double check the numbers Carol had questioned.

Motion - Jeff Brosbe made a motion to accept the Treasurer's Report; Karen Fidel seconded. The motion was passed unanimously and the report was accepted.

Membership - Karen Fidel reported that we are in the middle of the membership renewal timeframe. Two currents members have decided not to renew for personal reasons, and four new members were signed up after the gallery reopened.

Publicity/Nominating Committee Report - Grace Swanson reported that the nominating committee is presenting the following slate of candidates for the SDAG board for the next year

Grace reported that we don't currently have someone to take over the website but that Jeff Brosbe will continue to recruit and Grace offered to manage it in the meantime.

Motion - Grace Swanson made a motion to accept the proposed slate of board nominees as presented; Karen Fidel seconded. The board voted unanimously to accept the slate of nominees for election by the membership.

Regarding Publicity, Grace continued that her research into an online platform for gallery sales is progressing well. She continued that she is working with Michael Winters and Peter Lanham to identify the best platform. Grace assured the board there would be no changes to our website per se but there will be links to the online shopping site from everywhere possible. Grace continued to share with the board aspects under consideration for the new site, and also answered several questions. These included how many pieces each artist could put on the site at a time, who will doing the shipping of sold work, how will artwork be photographed, and how the Guild profits (submission fees and commission, much like a monthly show). Grace will be continuing to work on these details and will keep the board apprised of progress.

Social Media - Linda Melvin gave Julie Swartz a warm welcome and introduction as the board's new Social Media Chair. Welcome Julie! Julie Swartz began by reporting her goal to increase the gallery's followers and "Likes" by 25%, with the intended result to increase sales. Julie expressed her support of the idea of the online store and agreed to work with Grace in terms of the social media aspect. Julie continued that she wants to see an increase in use of constant comment for sharing more email messages and photos both of monthly show winners and also pictures of patrons with the art they buy.

Cheryl Ehlers added that she has a release form that can be used to get permission for photography of patrons (which she will send to Julie). Carol Korfin will request that staffers take photos and have the patrons sign the form. The forms can be put into Julie Swartz's folder in the office and the photos emailed to Julie for publication.

Calendar - Carol Korfin reporting about our EIDL application, said that she is awaiting word on status from the bank. The bank would have received the signed papers on the previous Friday. She described issues pertaining to the liability of the signing party and efforts to make the wording acceptable such that the member signing for the guild is not personally responsible for the loan in any way. The matter was resolved to our satisfaction. Carol reported that the calendar for staffing is working smoothly, and we will continue the online sign up process going forward. Carol reported that she and Cheryl DeLain attended a zoom conference on how to renegotiate a lease during a pandemic, presented by a local real estate lawyer. Carol and Cheryl plan to come back to the board if they can present a recommendation as to how to renegotiate. They are pursuing a ten minute call with the presenter to discuss our case in particular. Carol will work with Cheryl Ehlers to get a copy of our current lease for reference.

Wall Chair Report - Debi Buffington reported the following changes to the wall display artists: Artists leaving the wall: Holly Wolfe leaving in August, Margot Carrera- put back on waiting list, Diane O'Connell- leaving in October New wall artists: Kathleen Graham, Betty Byrd, Abbey Chamberlain coming on in October. Debi continued to report that there are three on the wait list currently and that we could use more on the list. New jurying will begin on Aug. 20

Floor Chair Report - Lily Pourat reported that she sent out the rotation schedule with two display artists at a time for social distancing. Lily also reported that the next jury session would be approximately August 20th with extended drop off, jury, and pickup times over a number of days to avoid gathering of people.

Jobs Chair Report - Jeff Brosbe reported that he is having a difficult time finding a new web liaison. He will continue to recruit for this position. Jeff also reported we have a new rotation "map" person who will handle both wall and floor positions; he will introduce this person to the wall and floor chairs.


Monthly Show - Cheryl Ehlers reported that the current

monthly show is full, with many large pieces, and take in fees of over \$760. Regarding the November and December shows, Cheryl Ehlers proposed the December show be small images with a theme and limit members to two pieces each in order to get more artists in. This month the show filled up with some members not able to enter. (Note October is the Veteran's show).

Gallery Manager Report - Terry Oshrin and members of the Gallery Committee reported that the plexiglas shield has been installed at the desk to protect staffers and visitors during interaction and/or transactions. The restrooms in the complex will now be open until 8pm.

Guild Insurance Renewal - Linda Melvin asked the board to discuss renewal of our Directors and Officers Liability and Employment Practices insurance. The board discussed the level of coverage, potential for cost savings, and billing practices (online access, paper billing or no, and which board members will have access). Motion - Jeff Brosbe made a motion to accept the current quote from Hartford for \$2382 for an equivalent level of coverage; Karen Fidel seconded. The motion was approved unanimously.

Motion - Karen Fidel made a motion to adjourn; Lily Pourat seconded. The motion was passed unanimously. Meeting adjourned at 12:03 Submitted by Nancy Atherton West, Secretary

#### A Message to SDAG Members:

As you know, the Cavid19 pandemic has been a challenging time for the San Dieguito Art Guild and Off Track Gallery. But the President, the Board, and many of the members are rising to that challenge. Here is an update on what we have accomplished since March.

Due to the pandemic, we had to close the Off Track Gallery and cancel this year's Annual Mother's Day Art and Garden Tour. During the gallery closure from March 16, 2020 through June 7, 2020, we made no sales and collected no entry fees for the missed Monthly Shows. The cancellation of the Mather's Day Tour, which is our major annual fundraiser that keeps us afloat, resulted in an estimated revenue loss of approximately \$15,000. When the gallery finally reopened, our sales for the first month were half the usual amount. We are still in the process of determining July's sales. And as the pandemic continues, we will most likely cancel this year's Holiday Bazaar.

As if this wasn't enough economic excitement, our lease came up for renewal in March at the beginning of the pandemic. In spite of some concessions from our landlord for our nenewed five-year lease, our monthly expenses average over \$6,000/month when the gallery is closed and between \$7,000-\$8,000/month when the gallery is open.

And now for the good news! Fortunately, our display artists continued to pay their rotation fees during the gallery closure. In addition, many of our members made direct donations to the guild. Some of our members donated items they either made or grew that we were able to sell for donations. These outpourings of generosity and commitment were helpful and heart-warming as we all pulled together to keep our guild afloat.

During this time, SDAG applied for and received a \$1,000 grant from the SBA's Economic Injury Disaster Loan (EIDL) program under the CARES Act. We applied for and have been approved for a \$2,500 grant from the City of Encinitas under its Coronavirus Relief Fund (CRF). Our request for a grant from the County of San Diego's Small Business Stimulus Grant Program is currently under consideration. We also applied for and have been approved for an SBA EDL loan of \$44,600 at an interest rate of 2.75% with a 30 year repayment period (resulting in monthly payments of under \$200/month). Since we have no desire to saddle future guild members with these loan payments and thanks to the noprepayment-penalty terms, we intend to use this money anly if absolutely necessary and repay the amount not used as soon as we know we no longer need it as a back-up.

Our frugality during the fat times is serving us well in the lean times. We were able to enter this pandemic with a little over \$100,000 in reserves which, barring unforeseen circumstances, should cover our average overhead for approximately one year. While this helps us sleep better at night, we are also aware unforeseen expenses can erode these reserves quickly. But with the efforts of the board members and support of the members, we feel much more confident that we will be able to ride out this storm even if it lasts through next year. It is hard to believe that we are half way through 2020. This will be my last letter to you as the President of SDAG and I am waving to all of you as I leave. I will still be around spending time at the gallery and enjoying all of the wonderful art that is shown. During the last two years I have been so blessed to share time with new and existing members of the gallery and sharing memories and hopes for the future.



Please do not forget to vote for the new slate of officers for the Guild. If at any time you feel that you would like to take an active part of the board, please let the Membership Chair or the President Know. New people and ideas are always welcome. I would also like to thank the members that have made donations to the gallery during this trying time that we are all experiencing. The donations were greatly appreciated in order to help run the gallery.

Hope you all stay well and healthy during this time and looking forward to warm and sunny days ahead.


















### San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference August 24, 2020

Call to order: 10:06 by Linda Melvin, President

IN ATTENDANCE: Jeff Brosbe, Deborah Buffington, Cheryl DeLain, Cheryl Ehlers, Karen Fidel, Carol Korfin, Linda Melemed, Linda Melvin, Terry Oshrin, Lily Pourat, Grace Swanson, Julie Swartz, Nancy Atherton West, Marissa Wright.

ABSENT: Ellen Cramer, Julie Harris, Sandy Heath, Sharon Hoffman.

<u>President's Notes</u> - Linda Melvin asked who would be willing to take over setting up and monitoring the Zoom meetings going forward in September since Carol Korfin will be taking over the position of Treasurer. Karen Fidel agreed to take over the role as Zoom coordinator.

Linda Melvin reported that members are asking if we will be having the Holiday Bazaar this year. She continued that we are working with the city as to how it can be held, inside the Community Center or perhaps in the parking lot.

Linda reminded the Board that masks that have been donated to the Guild for sale are not taxable and members need to be trained not to charge tax on masks.

Regarding Diane Abadie's expression of concern over having to pay rotation fees during the closure, and her request for the Guild's financial reports/status, Linda Melvin said she will write her a letter with the financial information at the month's close. Linda reported that all other display artists had paid their fees during this time.

Regarding the issue of how many shrink wrap pieces each member may put into the gallery, with consideration of space available, Linda Melvin agree to take this matter to the Gallery Committee meeting next month for discussion. She will report back to the Board in the next meeting.

<u>Secretary's Report</u> - Linda Melvin asked for a motion to approve the Secretary's minutes from the previous month's meeting.

Motion - Karen Fidel moved to accept the previous month's minutes; Carol Korfin seconded. The minutes from the previous month were approved unanimously.

<u>Treasurer's Report</u> - Linda Melemed reported that as of July 31st, 2020 we had a total cash on hand of \$166,206. Artist sales year to date for the month ended July 31st were \$61,167 down from the prior year sales of \$86,952. Net loss Year to Date is (\$15,202) compared to the prior year loss of (\$4,251). The difference from the prior year is due to loss of Mother's Day income and closure of the Gallery for several months due to Covid-19 resulting in lower commissions from loss of art sales.

Motion - Karen Fidel made a motion to accept the Treasurer's Report; Jeff Brosbe seconded. The motion was passed unanimously and the report was accepted.

<u>Membership</u> - Karen Fidel reported that some members have not renewed their membership. The Board discussed that this is typical and it's natural to worry each year, but we expect to continue to get new members as well.

<u>Publicity</u> - Grace Swanson reported that the bookmarks advertising the first Saturday 10% off sale until the end of the year are in, there is a poster outside advertising the sales, and also an ad in the Coast News.

Grace Swanson reported on progress of building the Guilds online sales site via WIX. She asked the Board to approve \$2500 to support the creation of the site.

Motion - Jeff Brosbe made a motion to approve Grace's request for her committee to pay \$2500 for creation of the WIX online sales site. Cheryl Ehlers seconded the motion. The vote was unanimous in favor of supporting the \$2500 investment.

Some further discussion about the new online sales site included how might the Guild manage the level of quality of artwork put up on the site, and also the suggestion that in the future we could incorporate "auctions". Grace added that we will take one step at a time, beginning with a beta site presented to the Board, followed by opening up to the membership. We will build from there.

<u>Social Media</u> - Julie Swartz reported that the Guild is getting new followers with our increased social media presence and that she is getting good feedback. Julie acknowledged that it is hard to track any increase in sales due to increased social media presence and this time.

The Board brainstormed other ways to drive increased traffic into the gallery including putting a piece of art on an easel in the patio area outside the gallery (not allowed by the property manager), hanging of a piece of art on a "wreath" door hanger, taking videos of the monthly show judging process, and other videos that might be appropriate for social media.

<u>Calendar (Lease Renegotiation)</u> - Carol Korfin reported that she and Cheryl DeLain participated in a Zoom seminar sponsored by the San Diego and Imperial Valley Small Business Development Center. The topic of the seminar was renegotiating a commercial property lease in the pandemic. Cheryl DeLain prepared notes for the Board (see attached document titled Board Presentation, 8/24/20: Lease Renegotiation). Board members expressed a variety of opinions regarding the pros and cons of approaching our landlord for such a discussion. It was pointed out that we signed a five year lease renewal early in the pandemic. It was also reported that some other tenants had approached the property managers for lease renegotiation and none had had their rent reduced.

Nancy West suggested that since the next step of meeting with Robert Woods, an attorney recommended by the San Diego Bar Association, is free, there would be no harm in proceeding to learn more. Carol and Cheryl could then report more information to the Board at the next meeting or when appropriate. Carol Korfin agreed, pointing out that as a Board it is our responsibility to do everything possible to understand how to keep the Guild financially stable.

Motion: Grace Swanson made a motion that Carol Korfin and Cheryl DeLain take the next (free) step with attorney Robert Woods, and also contact Encinitas 101, non-profit community business support organization for any insight they may have regarding lease renegotiations for non-profits during the pandemic. Karen Fidel seconded the motion. The motion was approved unanimously.

<u>Wall Chair Report</u> - Debi Buffington reported that the last rotation went smoothly and that it's obvious we only need one hour time slots in stead of one and a half. She will be implementing one hour time slots in the next rotation which will be October 14th and 15th.

<u>Floor Chair Report</u> - Lily Pourat reported that the floor rotation also went smoothly. Lily reported that the next jury session for new display artists will be in the October 12th or 13th timeframe, with potential new artists dropping off on those days and jurors coming over the weekend. Essentially this extended time period provides for social distancing.

<u>Jobs Chair Report</u> - Jeff Brosbe reported that he sent out the current jobs report with changes to reflect the new Board Members being installed today.

Carol Korfin brought up the fact the the jobs report changes so constantly that perhaps it need not be on the website since it isn't always current. The Board agreed that the jobs report need not be on the website.

<u>Monthly Show</u> - Cheryl Ehlers reported that the monthly show has 25 artists participating, with 40 pieces, and most are smaller pieces. She continued that the streamlined take in methods are continuing to work well. Cheryl brought up that the printer is failing, putting lines on everything and it should be replaced. The Board approved and Linda Melvin agreed to purchase a new one.

On the topic of record keeping with respect to the By Laws, resolutions and ammendments, Cheryl reported that she was reviewing the records and compiling them properly for the benefit of the Guild. She will be working with Carol Korfin, Nancy West, and Cheryl DeLain to accomplish this. The Board expressed their approval.

<u>Gallery Manager Report</u> - Terry Oshrin said goodbye to the Board! All thanked her for her 11 years of service.

<u>Hospitality</u> - Marissa Wright reported that since her job is on hold due to the pandemic and no receptions, she is instead cleaning the gallery thoroughly each time she staffs.

<u>Newsletter</u> - Ry Beloin, new Newsletter Chair, reported that she has a draft of the upcoming edition and asked members to send her any content suggested and to do so in any format. She will edit and reformat as appropriate.

<u>Installation of new Board Members</u> - Cheryl DeLain performed the duty of announcing the members leaving, thanking them for their service, and installation of the new Board Members. A copy of her presentation is attached behind these minutes as a record of members voted in to the new Board.

Motion - Jeff Brosbe made a motion to adjourn; Carol Korfin seconded. The motion was passed unanimously.

Progress Report on Future Online Sales Venue for SDAG Members

Thank you to Pete Lanham who has been researching what is involved for us to build our on-line sales site. He found us a Wix website professional to build the site for us and the board

He found us a Wix website professional to build the site for us and the board approved funds at the Monday, August 24 board meeting to move forward.

We are adding up the costs making a lot of decisions about how the site should be organized, how postings will work, how the site will look, how much it will cost to submit each piece if artwork, how many you can submit, what percentage the guild will take, etc. There are a lot of things to consider.

We will construct a BETA site, present that to the SDAG Board and then to the Membership. After that process we will be open for you to submit your artwork for sale on the e-commerce site.

Here are a few of things you need to be thinking about NOW.

 You will need to put a lot of thought into why a customer should purchase YOUR artwork. You will need to submit a very short paragraph as to WHY your art is special and how it will enhance the life of your customer. 2. Your photograph. It needs to be SUFEKB. Over the top WONDEKFUL. Your photo and your description are ALL your customer has to go on. Your customer needs to make a decision based on photos and words only. If you need help taking a GREAT photo let us know. It is possible we can set up a photo session at the gallery to get you quality photos. When we know the specs we will let you know the size, pixel set. If you do NOT know this stuff when the time comes - ask us for help. In this age of digital and online photos - as an artist - this is something you NEED to know. know.

3. Description. Not only will you need to submit the size of your art, you must describe it in great detail. What is it made of? How it is finished? Is it framed or unframed? How did you make it? How should your customer care of it? How can it be displayed? What motivated you to make this piece of art? What does your artwork depict. Why do you think your customer should buy it?

4. SHIPPING. This is a huge deal.

You may opt for FREE SHIPPING. This means that YOU pay for the shipping. This is ideal for small, or lightweight pieces. Your customer is much more likely to purchase your art if you ship for FREE. In the age of Amazon – people are used to purchase your art if you free and fast shipping.

If you cannot ship for free, you MUST know how much your shipping will be. Suggestion: take a sample of your artwork with packaging box and material to the post office, to your nearest UPS or to your FedEx store and ask.

Some people decide that they will "eat" part of the shipping to make a sale (split the cost with your customer to make the shipping more palatable). This is up to you. Remember how many times you have been excited to purchase something online until you saw how much shipping was and decided it was not worth it.

You may opt for the customer to meet you at the Gallery and pick up your artwork. This will work for local sales only so will limit your potential client base.







Call artist about sale
 Tell artist that they should send a jpeg (if they have one) with the above mentioned information to Julie Swartz by text.
 If artist does not have Jpeg photo, your responsibility ends there.
 If they do have a jpeg photo, then also text or call Julie and leave a message that Gregg Sindici (for example) will be sending her a jpeg and information soon about his solid item. If no one is answering their phone, leave a full message to the artist so they can follow through, if desired. If we do this, the artist and gallery will get more coverage on social media and save time in the process.

## UPDATED PROCEDURES FOR OPERATING GALLERY RE: COVID19 (10.12.20)

All staff must either take their own temperature and be below 100 degrees before coming to staff or not have COVID19 symptoms (cough, shortness of breath, trouble breathing, or two of the following – fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell). All staffers must follow all County procedures posted on the front door. We will only have overlapping shifts for training or in holiday season.

- 1. Remember to call next day staffers. AM shift call Karla at 760.471.9650
- Calendars and Board members list are in plastic sleeves on side cart (if you need to call any of us). Don't use binders unless absolutely necessary. (If you use, clean cover and plastic covered pages with a disinfectant wipe after use)
- Don't use Member directory. On side cart, under the plastic is a list of members and their phone numbers to use when calling member after a sale is made and to call next day staffers. If no answer leave a voice mail or text( if a cellphone) These procedures will be under the glass, as well as instructions for cleaning the credit card machine. DO NOT SPRAY LIQUID ON CREDIT CARD MACHINE.
- We only take credit/debit card sales. No cash or checks. We do take Apple Pay, Google Pay and Samsung Pay. Have customer insert own card or tap phone to Elavon screen when it asks for credit or debit card.
- 5. We will not enter sales into sales log for this time period. Artists can check the pink copy of the old sales receipt books if need be. They are to be put in the side cart drawer when they are completed. New sales envelopes will be used as soon as soon as old ones run out. Next to receipt # mark when you call artists. Some artists have not been getting calls.
- 6. Bea Gold is donating masks for \$15 to SDAG. She does not get paid for them. Mark receipt SDAG mask and DO NOT CHARGE SALES TAX.
- 7. If you make a large sale, ask the customer if you can take a picture of them with their item. Take with your phone, have them sign a release form (in the desk drawer), and text it to Julie Swartz at 858.245.5524 so she can post it on Social media
- 8. It has been suggested that writing up sales receipts at the side cart keeps a safer distance from the customer.

## WHEN YOU ENTER GALLERY IN THE MORNING:

Have your mask on and keep it on. Don't use nametags.

- 1. Bring lock box and key in with you and open door all the way.
- 2. Turn on lights and unlock back door.
- 3. Use disinfectant wipe to clean key, lockbox, door handles, light switches, frame of sign, top of desk and side cart, drawer/door handles, phone, pens &

pen holders, stapler, calculator and tape dispenser on the desk. Put sign out front. Put lock box back after cleaning it.

- 4. In back office, for anything you touch,wipe with a disinfectant wipe (computer, printer, file drawers or safe handles.
- Wash your hands in back office at sink. Soap and paper towels will be by sink, along with trash container with plastic liner. (Happy Birthday twice!) ONLY STAFF CAN WASH HANDS IN BACK OF-FICE, CUSTOMERS WILL NEED TO USE RE-STROOM FACILITIES.
- 6. At the end of your shift wipe down all surfaces as you did in the beginning of it.
- 7. When afternoon shift arrives, ask them to read all instructions above.

WHEN CUSTOMERS COME IN: (There is a sign on the on the door with government and our guidelines). Leave door open. **No more than 10 customers allowed in at one time.** Floor is marked with safe distance markers. Keep wipes under or next to desk for your use. A station will be next to desk with hand sanitizer. **Do not let anyone in without a mask, worn properly, covering their MOUTH AND NOSE!** 

- 1. If they don't want to wear a mask, say we will be glad to welcome them back in the future when they no longer need to, but you are required to adhere to our procedures dictated by the county.
- 2. Ask **EVERYONE (even members)** to use hand sanitizer in order to keep everything in the gallery sanitized.
- There are two pen holders on the desk. One "Sanitized". One "Used". Have them use one from the sanitized holder and put it in the used holder. At end of your shift, wipe down ones in the used holder and place in the sanitized holder.
- 4. DON'T enter sales in sales log, but DO ENTER SALES ON YOUR WHITE ENVELOPE and put your envelope in the safe at end of your shift.

## Vilma Malmberg

It has come to our attention that Vilma Malmberg — the last of the 12 founding members of SDAG — passed away on October 18, 2018. She was 88. On June 8, 2013 a very special artist reception was held for her at the Off Track Gallery.

SDNEWS.com reported that: "Vilma's art interest started at age three. Fast forward some years, she majored in Art Education and picked up a few scholarships in Chicago, and taught art at the Illinois State University. Moving to California in 1958, she continued art studies at San Diego State. She saw art in everything. Traveling widely and living in both England and Japan, sparked her interest in Asian art. She continued to be inspired by nature, especially the western coastline and became proficient in pastels, watercolors and Chinese brush work. She is a skilled self-taught artist who is open to numerous styles' of painting and very good at interpretation."

She remembered the history of the San Dieguito Art Guild very well.

"One day in 1965 fellow artist, Sue Beere, called together friends and neighbors for coffee at her Del Mar home and together they mapped out a vision. There were no other art groups in North San Diego County at that time. The first people involved in the San Dieguito Art Guild were a mixture of people with a lot of art training or none at all. The main interest was to foster art and to provide a place to display it. We found a small storefront in Del Mar, our first gallery, and a lot of starving artist sales were used to pay the rent. The membership grew and flourished with some good years and some bad.

We managed to move around in three locations in Del Mar. The San Dieguito Art Galley rented the building where the Del Mar Library is now on the corner of 13th and Camino del Mar from 1969-1970. The building was the old St. James Catholic Church. During the time that the guild rented the building it was up for sale and Sue Beere and I wanted to buy it. I was prepared to put my own money into the building and get a mortgage. That did not happen. The building eventually was sold and became the Albatross Restaurant before it became the Del Mar Library. I was discouraged and to this day I still think about the memory that could have been".

At age 84 (at the time of her 2013 reception), Vilma was still active in the arts and a delight to speak to. She expressed her gratitude to her fellow artists, which she calls a "great group of gals". Her passion and love of art have kept her painting, which she simply states, "I love everything about it. My favorites are nature. These days, I am working on abstracts". She remains an active supporter and participant in the Guild's Monthly Show exhibits and a delightful role model for younger artists whom she encourages to participate in the guild.

"I care deeply about the San Dieguito Art Guild and what it represents. It takes a lot of volunteers and time to keep it going - they are very special folks and I am still proud to be part of the organization," says Vilma.


Over the years she has held numerous Guild positions; 1967 Publicity Chair, 1969-1970 Parliamentarian, 1973 member of the Ways and Means Committee, 1996-1998 Shrink Wrap Bins, Mother's Day Artists and Studio Tour volunteer, 1992 Mother's Day Tour docent organizer, and 2002–2003 Membership Chair Assistant. She has received numerous ribbons over the years for her many watercolor and pastel paintings and has been a member of the San Diego Watercolor Society and the Pastel Society.


Q: If a piece of artwork sells may I replace it and will there be a cost? A: For the first 6 months you may replace a sold item for free. Policy may or may not change after that.






## San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference November 23, 2020

Call to order: 10:01 by Patricia Watkins, President

IN ATTENDANCE: Ry Beloin, Jeff Brosbe, Deborah Buffington, Cheryl Ehlers, Marcy Evers, Karen Fidel, Sandy Heath, Carol Korfin, Haixin Li, Linda Melvin, Lily Pourat, Dolores Renner, Judy Richardson, Grace Swanson, Patricia Watkins, Nancy Atherton West, Marissa Wright.

ABSENT: Ellen Cramer, Julie Swartz.

<u>Secretary's Report</u> - Patricia Watkins asked for a motion to approve the Secretary's minutes from the previous month's meeting.

Motion - Dolores Renner moved to accept the previous month's minutes. Linda Melvin seconded. The minutes from the previous month were approved unanimously.

<u>Treasurer's Report</u> - Carol Korfin provided the following:

October Financial Summary -

On October 31st, 2020 we had total cash on hand of \$181,847. Artist sales year to date for the month ended October 31st were \$17,019 up from the prior year sales of \$12,722. Net profit Year to Date is \$9,616 compared to the prior year profit of \$9,982. The difference from the prior year is due to grant income of \$3,000 from the County of San Diego received in October 2020.

Sales for October, 2020 \$7,325 Sales for October, 2019 \$6,643

Motion - Judy Richardson made a motion to approve the October 2020 Treasurer's report. Grace Swanson seconded. The October financial report was approved unanimously.

Carol Korfin reported that our accounting firm has prepared our tax return and it will be signed by Linda Melemed, Treasurer from last year. She will sign in person to save the \$50 fee for electronic signature.

Carol continued that the Guild received a \$3,000 grant due to the pandemic from the County of San Diego in October and the funds were used to pay the November rent for the gallery. This has been documented per the requirements for the grant and the signatures needed are Carol Korfin and Karen Fidel. The documentation will be submitted today to the County.

Carol reported that she and Cheryl De Lain are awaiting a response from the property manager to schedule a meeting for discussion of possible renegotiation of our lease.

Carol reported on some recent problems in the gallery with the credit card system and also the internet. AT&T suggested a backup that turned out to be non-workable. AT&T was able to identify a technical connector problem outside of the gallery and this has been fixed. In the process of trouble shooting it became apparent that we are grossly overpaying Elevon, the credit card processing service. We have been paying 3 1/2% to 4 1/2% on transactions and we should only be paying 2%. Carol will present a proposal for cost savings at the next meeting. She also reported that using credit cards only (cashless policy) has been working well. She posed the question for discussion - should we continue with our no cash policy?

The Board briefly discussed the pros and cons of a no cash policy including health and safety, possible discrimination against customers who don't have a credit or debit card, and the fact that our error rates in accounting are far fewer with no cash. Nancy West suggested we continue the no cash policy at least until the vaccine is widely available. Carol Korfin agreed and proposed that we continue our cashless policy until the vaccine and/or government guidelines dictate differently. All agreed.

Carol Korfin reminded the Board that if the Elevon system does fail, the staffer should call Elevon for an authorization number and fill out an old fashioned credit card slip with the authorization number on the slip. Then the staffer should call Carol to let her know and Carol will handle the charge from there. Karen Fidel added that perhaps a reminder of our current no cash policy should be put in the Paint Rag.

<u>Gallery Manager Report</u> - Linda Melvin reported an edit to her Gallery Committee minutes emailed to the Board previously. It was reported that Linda would be sending a letter to a particular member who has exhibited less than stellar behavior toward other members during rotation asking for better coordination and cooperation with others. Instead, a letter from Patricia Watkins will be sent to all members urging patience and a better attitude during rotation especially during these times with all the extra health and safety measures.

Karen Fidel reminded the Board that because of the 25% capacity requirement during COVID for retail, we need to limit the number of people in the gallery at any one time to seven. Cheryl Ehlers volunteered to change our sign to reflect this requirement.

Linda Melvin reported that theft in retail spaces and other businesses has increased throughout Encinitas, hence gallery staffers must be even more vigilant, walking around the gallery observing all customers at all times. Another reminder is to make certain all locks are indeed locked when leaving the gallery. Patricia Watkins noted that she will publish a reminder for staffers of these important measures in the Paint Rag.

Carol Korfin asked for more details on a mention of going entirely to Paypal in the Gallery Committee Minutes. Deborah Buffington said detail would come later after the next Gallery Committee meeting is held and discussions and possible decisions are made.

Patricia invited Judy Richardson to ask the Floor and Wall Chairs about the rotation maps she had made for them last rotation, because apparently they were not used. Through discussion it was determined that Judy will make the map for future Floor rotations but that Deborah Buffington will make the map for future Wall rotations.

<u>Wall Chair Report</u> - Deborah Buffington reported that Karen Krugman is coming off the wall and Betty Byrd who is currently her half wall mate will take the full wall. Rotation is December 8th and 9th. Thirteen artists have not paid to date but will be reminded that their fees are due by the end of November. Deborah also reported that she had received some requests to jury for the wall.

<u>Floor Chair Report</u> - Lily Pourat reported that the next jury process will be virtual again, and that she would send out an email with details in the next day or so.

Lily raised the topic of non payment or late payment of floor display rotation fees by month's end, which is our polic. The penalty for late or non-payment is keeping the artist's art work out of the gallery for one week's duration. This week long penalty begins once the late payment is received by Lily. She expressed dismay that this penalty might leave some empty spaces. It was decided the current policy will stand for now and will hopefully motivate on time payments in the future. Patricia Watkins will call and remind those artists currently unpaid to pay before the deadline.

<u>Calendar</u> - Dolores Renner was asked by Patricia Watkins to review for her the details of her job as well as Sandy Heath and Ellen Cramer, who together make the Calendar management team. Dolores explained each members job in detail.

<u>Monthly Show</u> - Cheryl Ehlers reported that 123 pieces have been submitted for the Small Images show and of the 65 artists submitting, only 22 are Offtrack members. Hopefully this may lead to some new members. Take in for this show so far is \$1,085. The net from the November show was lower than usual at \$598 but Cheryl explained she believes this is due to approximately 30 artists having recently joined the Offtrack Marketplace online sales site, and the fact that membership dues were recently paid as well as rotation fees.

Cheryl continued that she is coordinating with Ry Beloin, Newsletter Chair, regarding take in dates for Monthly Shows next year, and that improvements are being made to the Monthly Show area of our website.

Jeff Brosbe asked Karen Fidel what our current membership is and Karen replied approximately 180, adding that it typically goes up by about 40 and down by about 40 each year.

<u>Publicity</u> - Grace Swanson reported that the online Off Track Market Place sales now has 26 artists participating. There have been five sales to date. and one inquiry from and artist outside of the area interested in displaying work on our site. Grace continued that artists outside of the area would need to become Guild members to show their work on the site, and although they would not need to jury, we do reserve the right to allow only quality work.

Grace Swanson reported that the Encinitas Small Business Saturday is coming up the Saturday after Thanksgiving and that 30% off tags would be available for artists who wish to participate by the end of Wednesday before Thanksgiving.

It was reported by Grace that our First Saturday 10% off sales in November were \$868, indicating that the discount does have a positive affect on sales volume. Dolores Renner asked if we plan to continue these monthly sales into 2021, since she would need to include them in the calendar. The Board agreed to continue the First Saturday 10% off sales into 2021.

Grace reported that the Lumberyard has created a Facebook and Instagram page and that she uploaded all kinds of good gallery publicity to them for inclusion. Grace will coordinate with Julie Swartz in this area as needed.

Grace reported that since Art Nights didn't happen due to the pandemic, and they didn't roll us over onto their 2021 list, we are waitlisted at this time. However, she continued that the organization is considering doing virtual art nights, with their staff coming into the galleries to create the video for the events. These would be available to viewers on their website and on our website as well.

<u>Jobs Chair</u> - Jeff Brosbe reported that he had identified three members to volunteer for the job of helping Membership Chair, Karen Fidel, with putting together the next Member's Directory. Jeff reminded members that when they request a volunteer for a job, that job should be at least two hours in duration of work, because the volunteer is excused from a four hour shift sitting in the gallery. <u>Newsletter</u> - Ry Beloin reported that the deadline for materials for the newsletter this month is November 28th at 9pm.

The Board briefly discussed reconciliation of event dates including special sales, take in dates, and newsletter deadlines. All Board members agreed to bring their calendars up to date with this current and future date information.

Social Media - Julie Swartz was absent due to her move and there was no report.

The Board continued the discussion of gallery security, the possibility of adding cameras, replacing the batteries in the existing "fake" cameras that will then move, and possibly an alarm system. It was decided that the Gallery Committee could take up this topic in a future meeting if warranted.

Motion - Jeff Brosbe made a motion to adjourn; Nancy West seconded. The motion was passed unanimously.







## San Dieguito Art Guild Board Of Directors Meeting Minutes via ZOOM online conference December 21, 2020

Call to order: 10:03 by Patricia Watkins, President.

IN ATTENDANCE: Ry Beloin, Deborah Buffington, Cheryl Ehlers, Marcy Evers, Karen Fidel, Sandy Heath (joined meeting at 10:30), Carol Korfin, Haixin Li, Linda Melvin, Lily Pourat, Dolores Renner, Judy Richardson, Grace Swanson, Julie Swartz, Patricia Watkins, Nancy Atherton West, Marissa Wright, and Cheryl DeLain (non-board member).

ABSENT: Jeff Brosbe, Ellen Cramer.

Patricia Watkins reminded the Board that it is Judy Richardson's responsibility to call on members before they speak during the zoom meetings as an aid to all hearing each other and the secretary taking accurate notes.

<u>Secretary's Report</u> - Patricia Watkins asked for a motion to approve the Secretary's minutes from the previous month's meeting.

Motion - Grace Swanson moved to accept the previous month's minutes. Linda Melvin seconded. The minutes from the previous month were approved unanimously.

<u>SDAG Annual Meeting</u> - Karen Fidel, Membership Chair, announced that the Annual Meeting of the San Dieguito Art Guild will be held via Zoom on January 30th, 2021 at 10am. For members new to Zoom, the meeting will include a half hour orientation beginning at 9:30. Linda Melvin will help the Apple users, and Carol Korfin will help the non-Apple users. Grace Swanson will send out a "Save the Date" for the Annual Meeting after the holidays. Karen advised that she will show a short video during the annual meeting, which was provided by Grace.

Karen reported that Laura Lowenstein will produce the 2021 Membership Booklet with help from Grace Swanson.

<u>Floor Chair Report</u> - Lily Pourat reported that all floor fees were paid on time by members for the last rotation. Lily reported that the jury process is fully online and that members may submit work at any time to be reviewed. She continued that we need more publicity of the jury opportunity to members. Ry Beloin asked if she should put a notice regarding the jury process in the Paint Rag, and it was agreed that she would.

Lily stated that she could use more judges. Patricia Watkins volunteered to be a judge.

<u>Treasurer's Report</u> - Carol Korfin reported that on November 30th, 2020 we had total cash on hand of \$177,201. Artist sales Year to Date for the month ended November 30th were \$23,739 up from the prior year sales of \$20,758. Off Track Gallery Marketplace (OTGM) sales Year to Date are \$416. Net profit Year to Date is \$4,783 compared to the prior year profit of \$7,623.

Sales for November 2020: Off Track = \$6,720. OTGM = \$416. Sales for November 2019: Off Track = \$8,024. OTGM = n/a

There were no questions and no discussion.

Motion - Karen Fidel made a motion to approve the November 2020 Treasurer's report. Dolores Renner seconded. The November financial report was approved unanimously.

Carol Korfin reported that she is continuing to pursue either a decrease in the rate we pay Elevon, our current credit card processing service or contracting with another company altogether. A rate review with Elevon has proved unsatisfactory. We currently pay Elevon approximately \$300/month; Carol is striving to save the Guild 1/2 to 1/3 of that amount. Carol continued that if we change companies we may need a different credit card processing machine. Finally, Carol suggested we would most likely make the change, if necessary, in the early part of next year when the gallery is slow.

Carol Korfin reported that she was able to make a reservation for the SDAG Holiday Bazaar at the Encinitas Community and Senior Center for December 4, 2021. She continued that the cost may be an additional \$50 if we want to use the kitchen.

Regarding the topic of lease renegotiation, Carol announced that she had received a response from Donna Bell at Cornerstone (the property manager) to the letter she and Cheryl DeLain had crafted, proposing a renegotiation of our lease because of the pandemic. The result is that Cornerstone will give the Guild a \$6,000 credit on our rent in the form of a donation back to the gallery.

<u>COVID 19 Stimulus Programs</u> - Cheryl DeLain reported that the County of San Diego has reopened their grant program and we have applied and are "in line" for approval. She noted that preference for grants will be given to businesses that have had to close and reopen multiple times. Also, the city of Encinitas has reopened their grant program and we are in line with them as well. At the federal level, it is expected that another relief package will be passed by congress as early as today. It includes the grant aspect of the EIDL program. Cheryl asked the board if there was any objection to her pursuing a second grant from the EIDL program; there were no objections. She also asked if we wanted to pursue the loan aspect of this program; it was agreed that we will not pursue another loan.

Cheryl DeLain continued by saying the federal Payroll Protection Plan (PPP) is also being reopened. She described the requirements of the PPP and reminded us that earlier in the year the Board had discussed applying for the PPP and deemed it inappropriate for our Guild, mainly because 75% of the money must go to 1099 recipients and if it wasn't approved as a grant, the guild would have to repay it as a loan and we would not be able to recoup what we paid out to artists so it would be a big expense for us.

Motion - Patricia Watkins made a motion that since it is believed at this time that the "terms" of the PPP are the same as they were in the initial roll out of the program, that we not pursue the PPP. Grace Swanson seconded the motion. The motion was carried unanimously.

10:30 - Lily Pourat had to leave the meeting. Sandy Heath joined the meeting.

<u>Temporary - Treasurer to become a signer at US Bank?</u> - Carol Korfin approached the Board with a request that she be given signature power for the Guild's affairs with US Bank for a temporary period during the pandemic such that she would be able to do online banking to a greater extent. Carol explained to the Board that our By Laws state that the Treasurer is not a signer for the Guild. Currently there are three signers, Karen Fidel, Linda Melvin, and Grace Swanson. But because of the health risks of going to the bank, handling transaction materials, meeting with the signers, it would put Carol at lesser risk to be able to sign herself.

The Board discussed the pros and cons of giving the Treasurer signing power, including the fact that the existing rule is a measure to protect the Treasurer from any potential accusation of

wrong doing. After further discussion, the Board agreed that Carol would be protected if she was given power to sign but also that every transaction she signs on behalf of the Guild is reported in writing to Karen Fidel.

Motion: Grace Swanson made a motion to grant Carol Korfin, Treasurer, signature access to the Guild's bank accounts with U S Bank immediately for a period of three months (to be reevaluated at the end of March, 2021) with the stipulation that all transactions will be documented in writing by Ms. Korfin to Karen Fidel, Membership Chair, who is also a signatory for the Guild's accounts. Karen Fidel seconded the motion. The motion was voted on and passed unanimously by a quorum of the Board of Directors.

<u>Wall Chair Report</u> - Debi Buffington reported that the next rotation will be February 10th and 11th. She continued that there are currently two artists who have juried in for the wall, but there are no empty spaces at this time. Debi continued that she will be attending the last part of rotation next time in order to give better instruction for clean up of ladders and other hanging materials at the end.

<u>Gallery Manager Report</u> - Linda Melvin reported that the next Gallery Committee meeting will be Thursday, January 21st at 1:00pm. Cheryl Ehlers reported that she had replaced the batteries on all the "dummy" cameras in the gallery. The Board discussed buying actual cameras that upload video to an app, but the question would be who would monitor the video.

Motion - Patricia Watkins made a motion that the Guild keep the "dummy" cameras and replace any that are no longer working. Karen Fidel seconded the motion. The motion was carried unanimously.

(Reminder - it was decided in the last Board meeting that the First Saturday 10% off will continue into 2021 until we resume participation in Encinitas Art Night.)

#### Calendar - no report

<u>Monthly Show</u> - Cheryl Ehlers reported that the Small Image Show resulted in gross sales of \$1,233 and net sales of \$1,080. There were 63 artists participating with 124 works. Cheryl commented that the show could probably have included another 20 small pieces. To date there have been eleven sales, of work by both members and non-members. The Guild gained three or four new members as a result of the "open" show. Cheryl suggested because of the success of the show that we consider having another open style show in the summer, perhaps in conjunction with Art Night.

Motion - Karen Fidel made a motion to approve another Small Image Open show in the summer to coincide with Encinitas Art Night, to be scheduled by Cheryl Ehlers. Patricia Watkins seconded. The motion was carried unanimously.

<u>Publicity</u> - Grace Swanson reported that the sales from the First Saturday 10% off in December were \$400 in gift cards and \$675 in art sales.

Carol Korfin added that the Small Business "Saturday" (SDAG participated for three days) after Thanksgiving resulted in sales of \$1,160 with \$327 with of that total being marked down items.

Jobs Chair - no report; Jeff Brosbe absent.

<u>Social Media</u> - Julie Swartz started a discussion of the process of obtaining photographs of work that has sold for the purpose of publicity on social media. Patricia Watkins clarified for the Board that it is the responsibility of the artist to photograph the work that they are

displaying in the gallery whether it be wall, floor, or monthly show. It is the responsibility of the staffer to call a member whose work has sold. Then it is the responsibility of that artist whose work has sold to send an image of it (suitable for publication on social media) to Julie Swartz. It was agreed by all that the communication of this process is needed. This will be communicated by the calendar team to staffers, in the Paint Rag to all members, and in addition, reminders to display artists from the Wall and Floor Chairs. Julie continues by saying she does go into the gallery to take photographs on occasion and will continue to do so.

<u>Newsletter</u> - Ry Beloin reported that the deadline for submissions for the newsletter this month is December 30th at 9pm. Ry and Cheryl Ehlers confirmed that for the Monthly Shows, the images that should be included in the newsletter are the Best Of Show, and First Place in each category. Ry will work with Cheryl each month for captions for the images.

Motion - Patricia Watkins made a motion to adjourn; Judy Richardson seconded. The motion was passed unanimously.

> 3D-Wall Hanging. Ceramic, glass, metal, wood, plastic, paper-mache, basrelief, or any other 3-D piece. Can be combined media 3-D sculpture. Wall Hanging or free standing.

> Printmaking. Must be original and not series of prints. Linoleum or wood block, etching, or monoprints. Collage (in one media). If more than one media enter in Mixed Media.

- > Encaustic
- > Copper Enameling.

> No Jewelry, Other Items, Unless in enclosed frame mounted for a wall.

## Sale of Art

 A 15% commission will be collected on all work sold. The Off Track Gallery collects sales tax from the buyer. Artists will be notified by phone upon the sale of their work.

## **Replacement of Sold Art**

The artist may hang another piece of the same size to replace sold art. Payment to the artist for sold pieces will arrive in the mail approximately one month following the sale.

## **Entry Rules**

- Maximum entry size for flat work is 12" square including the frame, 12" cubed for 3-D work.
- 2 entries maximum per artist.
- All paint must be dry. Do not bring in wet paintings.
- Works in paper must be under glass.
- All 2D works must have a multi-strand wire (not a saw-toothed hanger) attached securely approximately, and the ends of wire must be taped. Other hanging devices will be rejected.
- Work must be framed or gallery wrapped. (no staples on sides).
- Be sure your work looks as nice as it can, with clean, well put-together frame, free of marks, dirt, and clean glass.
- Reproductions/prints of original art (such as Gicleés) must CLEARLY be identified as such (but will not be judged).
- Work may not be withdrawn until the end of the show



# Judge for the Small Image Show, Julie Weaverling


